

RULES AND REGULATIONS

These regulations, (hereinafter referred to as "Regulations") were issued on the basis of the provisions of the Act of March 20, 2009 on the safety of mass events, OJ 2009 No. 62 item 504 (hereinafter referred to as the "Act") and on the basis of the provisions of the Civil Code.

I. General information

1. Organizer of a mass event (hereinafter referred to as the "Event") under the name "Festival Festival 2018 Music & ART" in the Garrison Modlin at ul. Generała Józefa Bema 200C on plot 6/32 line 3-09 in Nowy Dwór Mazowiecki is Groove Control Events & PR Sp. z o.o. hereinafter referred to as: "Organizer".
2. The organizer is responsible for the proper course of the Event in accordance with the requirements of the Act on Security of Mass Events, Op. OJ 2009 No. 62 item 504, as well as for fire safety.
3. The condition of ensuring the order and security of the participants of the Event is the absolute respect by all participants of the Event of the provisions contained in these Regulations, compliance with the provisions of criminal law and law on misdemeanors.
4. Equipment servicing the Event, being the responsibility of the organizer, is made and maintained in a standard that allows comfortable, cultural and safe use according to the purpose.
5. The purpose of the Regulations is to ensure the safety of the Event by defining the rules of behavior of people present at the Event, using the Site on which the Event is being held and using the devices located on the Site. In addition, the purpose of the regulations is to regulate the rights and obligations of the participants of the Event in connection with the purchase of an admission ticket to the Event.
6. The event is ticketed, available to the public on condition that the generally applicable rules of conduct and order in a public place are observed.

II. Organizational and policing rules applicable on the premises of the Event

1. The event takes place on June 22-23, 2018. In justified cases, the organizer may change the date of the Event, or it may be canceled, however, after a previous announcement.
2. The area where the event takes place is defined in the Situation Plan, which constitutes an attachment to these Regulations. In justified cases, the organizer may exclude some parts of the area designated for the organization of the Event, however after the announcement.
3. Participants of the Event are obliged to strictly adhere to the indications and orders of the organizers of the Event and the persons responsible for the Event.
4. The following terms used in the Regulations will have the following meanings:

"Ticket" means an individual consent to enter the Event, which at the entrance to the Event Area is subject to exchange for an Identifier (armband).

"Identifier" means an identifier issued by the Organizer at the entrance to the Event Area upon return of the Ticket. The identifier will have the form of a band placed permanently on the hand, the pattern of which is set by the Organizer. Only one person can use the ID. Damage or rupture of the Identifier causes its expiration. It is forbidden to withdraw the Identifier.

"Security Services" and "Information Services" mean persons appointed by the Organizer, including employees of a personal or property protection agency with ID, to care for the safety of persons

participating in the Event, including control of Entrants' entitlements to enter the Area of the Event. Members of Security and Information Services have identifiers placed in a visible place containing: name of the issuer, identification number and photograph, period of validity, stamp and signature of the exhibitor.

The area of "Events" means the interior area of the Modlin Garrison, or other place where the Event can be moved for important reasons and made public before the Event.

"Event Participant" means a person participating in the Event on the basis of the ID issued after the return of the Ticket at the entrance. A minor over the age of 15 may participate in the event alone, but is required to have their own document confirming the name, surname and age as well as the consent signed by the parent / guardian for the presence of a minor in the area of the Event. The Participant of the Event may also be a minor up to the age of 15, under the care of an adult, after purchasing Tickets for both a minor and an adult. In the case of a minor who is under 12, a 50% discount applies. For minors who have not reached the age of 3, the ticket is not required.

"Catering zone" is a separate and closed gastronomic and commercial zone, in which alcoholic beverages containing over 18% of alcohol and beer are sold. It is an area separated from the mass event area and only in this zone you can consume alcoholic beverages purchased there. There is also a catering service run by 9 foodtruck vehicles.

5. It is forbidden to bring inside the site of the Event:

- a) weapons,
- b) alcohol,
- c) dangerous objects and tools,
- d) explosives and pyrotechnics,
- e) drugs and psychoactive substances,
- f) poisonous and radioactive agents,
- g) flammable liquids,
- h) liquids in glass packaging
- i) drinks and foodstuffs
- j) professional cameras and video cameras (except cameras in mobile phones and compact cameras without an interchangeable lens)

6. Additionally, it is forbidden to:

- a) move on the premises of the Event by cars, with the exception of access roads to the car park,
- b) park cars outside places in parking lots,
- c) bring animals inside the premises of the Event,
- d) destroy information boards, benches, lawns and all objects of small and large architecture,
- e) enter or pass through fences, hoardings,
- f) enter areas not intended for participants of the Event,
- g) throw any objects,

- h) conduct any commercial and catering activities without consulting the organizer,
- i) sell, advertise, canvass and conduct cash collections without the organizer's consent,
- j) litter the area.

7. The security service has, in justified cases, the right to legitimize people and control the contents of luggage and clothing of persons staying at the Event. These persons are required to submit to the identification procedure aimed at establishing their identity, as well as submit to an external search and inspection of the baggage they have carried.

8. The security service is obliged not to allow entering a mass event persons against whom a decision has been issued prohibiting access to mass events, people obliged to refrain from staying in mass events, as well as people refusing to undergo the activities specified in point 6 above. Persons under the influence of alcohol or under the influence of other psychotropic substances, or persons refusing to undergo the activities specified in point 6 above, or disturbing the proper course of the Event will be removed by the security services.

9. In case of extraordinary events, all participants of the Event are obliged to follow the instructions given by the event organizer and the personnel of the security services. These commands may concern in particular: the necessity to leave the area of the Event in connection with the resulting threat, giving the way to behave, recalling the nearest exit points from the area of the Event, behaving in a strictly defined way that guarantees the safety of the participants of the Event.

10. The Organizer undertakes to comply with the provisions of the Act of October 26, 1982 on Upbringing in Sobriety and Counteracting Alcoholism (Journal of Laws No. 35, item 230, as amended), including subsequent amendments of 20 September 2012 (Dz. U. 2012 item 1356), in particular alcohol consumption is allowed only in designated places.

11. The organizer is entitled and obliged to implement the provisions of the Act of November 16, 2000 on counteracting the introduction to financial circulation of property values coming from illegal or undisclosed sources (Journal of Laws of 2000 No. 116, item 1216, as amended), in particular, to disclose and record suspicious transactions (when the circumstances of the transaction indicate that the funds may come from illegal or undisclosed sources) and to identify the persons ordering the transaction.

III. TICKETS SALE:

1. Tickets are sold only at authorized points of sale and at the Organizer. Tickets may be sold only at the price printed on the Ticket. A list of authorized points of sale is available at www.technoinstytut.pl

2. It is forbidden to resale Tickets at auctions, auctions or conducted in any other way indicating the commercial nature of such resale. Any public offering of the transfer of ownership of Tickets, including as prizes in competitions, lotteries, bonus sales or any other promotions, even if it is free of charge, is forbidden.

3. The organizer informs that in accordance with art. 133 of the Act of 20 May 1971. Code of offenses: "Anyone who purchases tickets for artistic, entertainment or sport events with a profit or who sells such tickets for a profit, is subject to arrest, restriction of liberty or a fine. Attempting, inciting and help is punishable."

4. Only the original ticket could be exchanged for the Identifier, acquired in accordance with the provisions of these Regulations. A ticket purchased in violation of the Regulations may be canceled by the Organizer. The organizer warns that the purchase of Tickets from third parties carries the risk

of buying a counterfeit ticket, which in consequence causes refusal to exchange the Ticket for the Identifier and entry to the Event.

5. Admission to the Area of the Event is vested in the person holding the ID card and the Ticket, which at the first entry to the Event Area will be exchanged for the Identifier.

6. Participants of the Event and all persons at the Event Venue are required to have a valid ID on hand. The lack of an ID or possession of a broken or damaged ID as well as an ID not held on hand is an unambiguous basis for removing the participant from the Event area. In the event of breaking or damage of the Identifier (on the premises of the event), the Event Participant is obliged to immediately report to the Security Manager at the exit gate from the Event Area along with the damaged ID, in order to exchange the ID for the new one. Only Identifiers damaged at the Event Site can be replaced.

IV. RIGHTS AND OBLIGATIONS of the Organizer and Participants of the Event:

1. The organizer of the event is entitled to record the event, and in particular the behavior of people, using the devices recording the image and sound.

2. Persons disturbing public order or not complying with the provisions of these regulations shall be removed from the event area by the Security Service, and in particularly dangerous cases will be detained and handed over to the Police or City Guard.

3. In the event that the actions of the Security Service prove to be insufficient, it will ask the Police for help.

4. In the case of discovering in the contents of person's luggage or clothing items, which possession at the Event is prohibited, a member of the Security Services refuses to let this person in and removes the person from the place of the Event.

5. In the case of finding weapons or other dangerous items, alcoholic beverages, explosives, pyrotechnics and fireworks as well as narcotic and psychotropic substances in the contents of the baggage or clothing being viewed, a member of Security or Information Services shall recognize the person in whom luggage or clothing these items have been found and after receiving them, draw up a report of this activity, and then transmit this person to the Police along with the items received.

6. Persons who have been denied access to the Event or being on it or persons removed from the Event Area in accordance with the Regulations or the Act due to their violation shall not be entitled to a refund of the Ticket fee.

7. The Organizer also records the course of the Event for the purpose of documentation and promotion or advertising of Event and events in future years, the Organizer and sponsors. The image of people staying at the Event site can be recorded and then distributed for documentary, reporting, advertising and promotional purposes.

IV. COMPLAINTS:

1. All complaints may be submitted in writing at the latest within 14 days from the day of the end of the Event to the following mailing address of the Organizer: Groove Control Events & PR Sp. z o.o., ul. Wawelska 5, sects G, 02-034 Warsaw.

2. The Organizer recognizes submitted complaints within 21 days from the date of their delivery to the Organizer by registered mail.

3. The condition for pursuing claims is to exhaust the complaint procedure referred to this chapter of the Regulations.

V. CRIMINAL PROVISIONS RESULTING FROM THE ACT:

1. Whoever does not execute order orders, issued on the basis of the Act or by the Security Or Informational Services, shall be subject to arrest, restriction of liberty or a fine.
2. Whoever brings or possesses weapons at the Event, other dangerous objects, explosives, pyrotechnic articles, fire-hazardous materials or drugs and psychotropic substances is subject to the penalty of arrest or restriction of liberty.

VI. FINAL PROVISIONS:

1. All rights to the name and logo of the Event are reserved for the benefit of the Organizer. Official programs and gadgets regarding the Event will be sold only at the Event Venue or at points of sale authorized by the Organizer.
2. Only the Organizer grants the status of the Event's sponsor.
3. The organizer is not responsible for the effects of force majeure.
4. These Regulations are available:

5. Correspondence to the Organizer is directed to the address indicated in point IV.1. Regulations in writing, by registered mail.
6. Security and Information Services may issue their own safety and fire-fighting instructions. in accordance with applicable law.
7. In matters not covered in the Regulations, the provisions of the Act shall apply.
8. The Regulations enter into force on June 22, 2018
